It is proposed to remove one Ash and one Horse Chestnut (T1 & T2 on sketch plan) and to prune one Holly hedge (H3) to 3m. See supporting document for reasons.

To mitigate, two new standard-sized trees will be planted within the rear garden (a Silver Birch and a Rowan).

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
