The business has been running successfully and safely for over 3 years since the extension and increase to 32 children. It is now clear that the volume of traffic submitted in the access statement was not as heavy as first perceived. Numerous parents do walk due to our central location, share transport due increasing costs and bring multiple siblings to minimise travel. With the change in government funding the demand for childcare is ever increasing and parents are requesting younger siblings to attend the nursery from the age of 9 months in Apr 24. Parents are finding it extremely disappointing when local nurseries cannot accommodate siblings to help reduce their daily burden. Notts County Council are encouraging all nurseries to consider options of expansion to support parents on the new government incentive. The impact of No increase will foresee numerous parents being disadvantaged to the funding opportunity in Ollerton/Boughton villages and considering separate nurseries for siblings creating unnecessary upset.
