This application for a Lawful Development Certificate is sought in line with the Permitted Development guidance published on the Welsh Government website.

The installation by Deco Heat of the external chimney/flue for an internal multi-fuel woodburner (model = Chilli Penguin Woody Stove) was completed on 8 January 2024, following several reviews with Deco Heat and HETAS on minor detailed revisions. The external chimney/flue has been affixed on the external west wall and bracketed to both the wall and roof and "does not project by more than 1m from the highest part of the roof".

A HETAS Certificate (with reference number 1682047) was provided dated 8 January 2024, confirming the works had been completed. Further, an email was received from HETAS on 18 January confirming that "remedial evidence had been received and reviewed" and that the works were "deemed as compliant by the HETAS Technical Team".
