TG1 Mixed spp. group of mostly Juniper, Elaeagnus, Philadelphus, Yew, Privet and Bay of the MWA Arboricultural Report Works: Remove (fell) all to near ground level and treat stumps to inhibit regrowth.

Reason: Clay shrinkage subsidence damage at the property.

Note: No S211 is deemed necessary prior to carrying out recommended works to SG1, HG1 and HG2 of the MWA Arboricultural Report.
