


**ROOF COWL**

VENTILATION NOTES

- 1. DRAWINGS SHOULD BE READ IN CONJUNCTION WITH RELEVANT EXISTING ARCHITECTURAL AND STRUCTURAL ENGINEERS
- 2. ALL DUCTWORK SHALL BE FIRE RATED IN ACCORDANCE WITH BS 9999 AND BS EN 1366.
- 3. ACCESS DOORS AND TEST PLUGS, TO BE INSTALLED IN LINE WITH REQUIREMENTS OF BESA DOCUMENT TR/19.
- 4. DUCTWORK ROUTES TO BE CO-ORDINATED WITH STRUCTURAL ELEMENTS. ALLOWANCE SHOULD BE MADE WITHIN THE DUCTWORK FABRICATION DRAWINGS TO TAKE ACCOUNT OF ALL SET-UPS AND SET-DOWNS IN DUCTWORK AND TRANSFORMATIONS ONTO.
- 5. ROUTING OF EXTERNAL DUCTWORK SHALL BE AGREED ON SITE.
- 6. SHEET METAL DUCTWORK INSTALLATIONS SHALL BE IN
- ACCORDANCE WITH THE FOLLOWING HVAC SPECIFICATIONS: DW144: SPECIFICATION FOR SHEET METAL DUCTWORK 1998 EDITION AS PUBLISHED BY THE HEATING AND VENTILATION CONTRACTORS ASSOCIATION.
- DW143: A PRACTICAL GUIDE TO DUCTWORK LEAKAGE TESTING. DW172: SPECIFICATION FOR KITCHEN VENTILATION SYSTEMS
- TR/19: GUIDE TO GOOD PRACTICE: CLEANLINESS OF VENTILATION SYSTEMS.
- 6. ALL EXTERIOR DUCTWORK SHOULD BE SUPPORTED WITH SUITABLE FIXINGS. CONTRACTOR TO PROVIDE CALCULATIONS BY STRUCTURAL ENGINEER (CONTRACTOR DESIGN PORTION).
- 7. ALL EXTERNAL DUCTWORK SHALL BE PAINTED IN ACCORDANCE WITH DW/144 TO AN AGREED RAL COLOUR.
- 8. DRAINS SHALL BE INSTALLED AT THE BASE OF ALL RISERS
