

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 Oak, crown lift 2 lowest branches over garage on south side only, cut back to the stem, finish height 3m cuting no greater than 50mm, touching garage.

T2 Oak, 1.5-2m height reduction on Left stem cutting no greater than 100mm. hwight form 8m to 6m

T3 Beech, Lift lower crown to 5.5m on all cardinal points, ct branches back to main stem, cutting no greater than 100mm, reduce upper crown by 2-3m vertical height, cutting no greater than 50mm, lateral reduction on all sides 2-3m cutting no greater than 50mm, crown reduction from 18m to 16m, lateral spread reduction from 12m to 8to NGP in line with BS3998. tree is very large for the garden space, low branches mean parts of the garden cant be used, worries of roots in the old Devon bank and the trees wind loading in storms, a reduction will reduce the sail effects.

T4 Hawthorn, pollard, leaving finish height 2.4m, cutting no greater than 75mm, tree is tall and leggy, wanting to bring back to a smaller size, (possiby not old enought to be in TPO)

T5 Thuja/ Cyress, 5.5 m crown lift on all sides, cutting no greater than 50mm. low branches mean parts of the garden cant be used,

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
