## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

We have over 50 beech trees in poor condition along one side of our property. These are approximately 14 metres in height and are rooted in a raised mound of earth. Bearing in mind beach trees are surface rooted we believe that they are in danger of blowing over causing damage to ours and our neighbours property and persons. (The trees are sited in very close proximity to ours and our neighbouring properties). There is also a possibility of the trees falling on to the road Bovingdon Green and therefore endangering the public.

These, along with a huge oak tree, cause a lot of damage to our property (we have glass lantern roof lights and velux windows) and potential risk of harm to health to us and our small children, i.e. falling branches, excessive leaves (which killed our lawn within 2 weeks while we were away this year) requiring daily clearance in autumn, blockage to gutters and drains, dirt and staining to paving and patio, excessive bird mess to many areas needing to be used by the children (creating health issues, especially if walked in, picked up or eaten by our young children), unable to maintain a lawn, previously newly laid in 2021.

We would like to remove the beech trees and replace with a more manageable alternative, so that we can enjoy privacy in our garden without the added stress and anxiety caused due to the issues listed above. We cannot use our garden at all as it is muddy in the winter and in the summer, we are trying to grow new grass, so therefore cannot be used then either. This impacts us as a family massively and is seriously affecting our mental health as we are stuck in our house when we could be using the garden.

Since our house is situated on a small plot with over 50 trees including a massive oak tree, as well as potentially falling over, the leaves that fall daily during autumn fill our two green waste bins daily. These bins are collected every 2 weeks so we have dispose of these surplus leaves elsewhere at extra cost over and above what we pay to the council already.

We have added photos of our property in 2021 when new lawn was laid and also recent photos in Feb 2024 so you can see the damage caused by the massively excessive leaf fall on our property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
