T1 - Ash tree with advanced dieback located within the grounds of TRU head injury residential care home, growing in close proximity to buildings.

T2 - Ash Tree with advanced dieback located within the grounds of TRU head injury residential care home, growing in close proximity to buildings and

adjacent to busy A58 near Ashton Cross junction.

Both trees have significant dieback in the upper canopy, trees have been monitored over the past 18months and their decline is imminent and at pace.

Request to fell.

Replanting project in planning which includes the planting of 2no Oak, 2no Beech, 2no Liquidamber.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
