T1 and T2 are Alder trees which are situated at the foot of our garden next to the border of our neighbours property at number 12 and they are on the river bank of Syd Brook. I am aware that numerous trees (believed to be 11 trees in total) at the rear of numbers 6, 7 8 and 9 have been totally removed between 2016 and 2020. Our situation is slightly different as we do not wish to totally remove the trees. After liaison with the environment agency, their recommendation was to leave the trunks in situ as the roots form part of the riverbank and total removal could lead to further erosion. What was suggested instead, was that the height of both trees should be reduced, to minimise the possibility of one of both becoming unstable if the riverbank erodes more or strong winds cause the trees roots to come away from the riverbank. T1 (the left tree is already leaning more towards the river since we moved into the property in 2019 and the roots are more exposed due to previous flooding and continued persistent rainfall in the last couple of years which often causes the river to swell. Our proposal would be to reduce both trees height by approximately 10 feet, utilising a tree surgeon capable of carrying out the work in accordance with BS 3998 standards.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
