Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

To remove the substantial deadwood from the Oak tree by the exit of Edge Grove school that leads onto Radlett Road. This is to prevent any injury that may be caused by falling deadwood to any pedestrian walking past or any children playing underneath the tree.

To cut back, to suitable growth points nearest the purple line shown in 'Photo Reference 1 - Oak Tree' and 'Photo Reference 2 - Oak Tree', the 6 (approximate) branches overhanging the road so vehicles can pass underneath (height indicated by the red line in the above 'Photo References') with suitable clearance. This is to prevent damage to vehicles and any potential injury to motorists should they come into contact with the branches.

To crown raise, to the height shown by the blue line in 'Photo reference 3 - Oak Tree' one branch over the footpath that could potentially interfere with pedestrians should it not be dealt with.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
