All scotch pines

T1 T2 T3 T4 T5 T6 to be removed

T1 T2 are in poor form with stunted growth

However the trees assessed (T1 - T6 inc) have varying degrees of lean and overhang the rear garden with three being within reach of the conservatory and building these are categorised as high occupancy target areas being constant features beneath these trees. The conservatory offers minimal protection should failure occur with the potential to cause significant damage and injury to the occupants.

T7 requires serious deadwooding

T8 to remove LH limb to mitigate failure

T9 to remove damaged limb

The trees in question have limited visual amenity value and their presence on the landscape is restricted to the one residential properties.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
