All below surveyed by qualified tree surgeon.

Job 1, Reduction of ash tree within 2m of domestic garage. Limbs overhang structure with the possibility of damage to the garage during storm conditions.

Job 2, Reduction of Lyme tree with one of several large limbs. One large limb leaning within 5m of garage with possible damage to garage during storm conditions. Possible disease to base of tree.

Job 3, Large diseased oak tree limbs within falling distance of domestic stables. Large sections of tree have already fallen to ground around the base of the tree. Tree within 15m of stables.
