| The what3words location is ///yarn.noises.funny. It is a large, twin stemmed sycamore, that leans over an electrics box, and towards a residential property/garden- see attached photos. It has decay and a crack at the base, where the 2 stems meet. It also appears to have damage/dead bark/decay at approx 10 ft high on one stem. Due to the location, apparent issues identified we wish to fell both stems to the ground. | | |
| I have another application in for a very large sycamore close to this one, and it would be prudent to carry out works at the same time. | | |
