I have been advised by my tree surgeon (Treescape Tree Services, Abergavenny) that 3 of the Beech trees have now reached approximately 100 feet height and, given the proximity to the wall the height of the trees and the strengths of winds coming down Pen-Y-Pound should be reduced in height by approximately 25 feet.
