The amendments remain within the footprint of the plans approved in 2021 (Ref 21/0698/HOU). The south elevation would have a slightly smaller window at the front of the house and the doorway approximately one metre away from that window. Internally, the layout is somewhat simplified, with far less re-structuring of the main building and a smaller opening from the existing kitchen.
