T1 Silver Birch; clean out canopy by removal of crossing/rubbing branches T2 Oak; reduce over-extended lateral limbs by up to 2m. This tree has previously been heavily pruned/pollarded & this will relieve stress on this part of the tree T3 Beech; prune new growth to previous reduction points
T4 Willow; fell this self sown leaning tree which is growing up through the Laurel hedge.
T5 Oak; fell this tree which is growing towards the house & replace with another in a more suitable part of the garden. T6 Oak; prune new growth back to previous reduction points
T7 Silver Rirch: fall this tree which is leaning towards the neighbouring property & replace in the same area

T8 Sweet Chestnut; prune back from telecom cables

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
