The front elevation is finished in Forest Green Cedral cladding, Brickwork is a buff / yellow faced brick. Roof tiles are red /brown plain concrete. Windows & doors are White UPVC Fascia, Soffits and gutters are White UPVC. Flat roofs are layered mineral felt.

Proposed materials and finishes:

First floor extension The new walls to the bedroom will be finished in the same Forest Green Cedral cladding. The roof will be Rubberbond EPDM covering with black trims. Fascia, soffit and gutters to be in White UPVC. Sun room alterations Extensions to brickwork in buff / yellow to match. Timber flat roof, with Rubberbond EPDM covering. White UPVC fascia, Soffit and gutters. New lantern in White UPVC.
