Part Change of use of a residential curtilage - Planning Permission

I am writing to submit a planning permission application for the part change of use of a residential curtilage at 17 Clifton Avenue PL7 4BH. The building concerned is an existing single storey garden/utility room attached to the rear of our garage and this proposal is to change its use to a nail salon. No additional development is needed.

The purpose of this change of use is to allow myself Corey Sunderland, to operate a self-employed nail business from home, thereby providing a convenient and appointment only accessible service to the local community. With my partners job taking him away during the working week, by working from home I can maintain a better work life balance caring for my 10 month old daughter.

This application proposes the part change of use of the existing garden/utility room attached to the rear of the garage to a nail salon. The nail salon would be a small facility designed to carry out 1 in and 1 out appointments for clients and is proposed to operate between 09:00 - 17:30 on Tuesdays, Wednesdays, Thursdays & Fridays.

Nail treatments shall be undertaken by prior appointment only and appointment diaries shall be made available to the local planning authority on request. Appointments are to be dealt with one customer at a time with a 20 minute gap in between appointments. The 20 minute gap allows the client to vacate the premises and the car parking space with sufficient time before the next client would arrive. The number of customers will be limited to no more than 5 per day and 15 per week.

In order to accommodate clients between 09:00 - 17:30 with a 20 minute gap in between, this application requests for Tuesday through to Friday which differs to the request in the pre application. In the pre application I requested to operate between 09:00 - 19:30 two days a week with the potential of extending to three days a week. Finishing at 19:30 was suggested to me as unacceptable as it could have more of an impact on the amenity of local residents. Taking this response into consideration this is why I am requesting Tuesday through to Friday at reduced hours.

The room would be accessed externally through the side gate between the house and the garage and via a rear entrance door into the nail salon.

There will be designated parking on our driveway for clients so to not cause any disruption on the road or to neighbours.

There is no proposal to advertise externally to the building as I would not want to disrupt the aesthetics of the neighbourhood.

Being a nail technician has always been my dream job and It has taken years to finally get to a point in my life where I can now do it from home. I would greatly appreciate a positive outcome from this application.

I assure you that I will comply with any additional conditions or requirements set forth by the local authority to ensure the safety, wellbeing, and harmony of our community.
