Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

I am the homeowner and wish to carry out general maintenance and pruning of the trees located on and bordering my property, as follows:

- 1 - Beech tree. Located on the property boundary, bordering 49 Elloughton Road. Owner: Mr Daniel Harper, permission for works granted. We propose a 30% crown reduction to the tree, to ensure the long term safety of the tree and garden occupants from falling limbs. These works will also allow more light and prevent excessive shading in the garden.
- 2 - General tree canopy - Works to maintain and prune the canopy, removing any dangerous or protruding limbs, reducing the overall crowns by around 10%
- 3 - Yew tree - has not been maintained by previous owners and is now overgrown. Is causing excessive shading to the bottom of the garden and not allowing light. Propose felling. Replace with laurel, ferns and wild flower area, encouraging butterflies and general biodiversity.
- 4- Fir tree - Limbs are encroaching on to the building. Pruning back of overhanging limbs onto both the house and the roadway, by around 3ft.
- 5- Arborvitae - Remove around 3ft of height and prune to regain original box shape, allowing more light into gardens.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
