1. There is a large beech tree in the garden which has been neglected since the last works were carried out (11/01928/TPOS and TPO.TVBC.00681/4) by the previous owner of the house, due to ill health. The large branches of the tree are hitting against the house and also the telephone wire that is adjacent to the tree. I would like to trim the branches back to the state previously agreed (3m from house) and away from the telephone wire.

2. The Silver Birch in the garden is dead at requires felling due to the proximity of the tree to the road, the pavement and the children that play in the garden. The neighbours have stated that the process was started by the previous owner of the house, but i do not have any paperwork that was left when we bought the house a month ago.
