T 1 Horse chestnut. Reduce the total canopy by 2 metres and bring the left side as look at the tree from the house in harder to balance the tree up. Raise the canopy over the road to 5.5metres and reduce the over extended branches back from the house by 3 metres. All work will be to BS 3998 2010 and carried out by professional and qualified tree surgeons.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
