Cedar - (T1) - Reduce the lateral branches by 2-3 metres on the Cedar tree that overhangs the garages at 40, Broadwater Down. Cleanout any deadwood and remove any branches that are badly damaged or weak. Sever the lvy at the base of the tree.

Reason ; Reduce the risk of branches falling onto the garage roof below.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
