

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out		
Re -Pollard 6 x Tilia Cordata to previous pollard points, these trees form the western boundary of the rear lawns, behind houses on The Avenue (B1103).		
Begin a staged reduction of 6 further mature Tilia in the same location, with the eventual aim of producing pollards, whilst reducing by no more than 25% in one year. This will mitigate the risk posed by the varying amounts of dead wood present and bring them in line with management of the other trees on site.		
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
