We would like to create a year round glamping site consisting of 4 shepherd huts on the 0.49 hectare area within a 0.9hectare field. The field has been used for the past 3 summers as a venue to host weddings under permitted development.

The huts will be built off site and towed onto the land. We want to install a wastewater treatment plant and drainage field and trenches for the pipe work that will connect each hut to the main sewage tank. Once the groundwork has been completed the trenches will be filled in and the grass will be reseeded, the only structures left on view will be the manhole covers.

There is already a farm track running up the side of the field from the road gate, a parking space for each hut will be created just off the track. For each parking space the earth will be removed down to the chalk and gravel will be laid on the chalk and compacted, allowing the rain water to drain through but leaving a firm surface for a car to be parked on.

The area around each hut will be planted up with hedges and trees for screening, wind breaks and privacy.
