I have a non-native Trachycarpus in my back garden, which has become too large (approx 15-20 feet) for the size of the garden, and is competing for light with the native Hawthorne and two apple trees. It was planted by the previous owner on the raised corner of the site of an old pond, compromising its stability, and is within 1 metre of the garage.
I have consulted with an arborist, who agrees that it is compromising the native trees and could pose a danger to the garage because of its close proximity. It is not protected by a specific tree preservation order but as I live in a conservation area, and it is quite large, I am seeking approval to have it removed.

  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
