1x Ash in rear garden to be fully removed. Tree is very tall and close to house - if it fell in a storm it is range of the house and could cause damage. (#1 on sketch plan). Tree is about 40ft tall and about 20ft from house.
1x plum to be fully removed . Small and in poor condition. (#2 on sketch plan)
1x cherry to be fully removed. In poor condition. (#3 on sketch plan).
