Identification of Tree(s) and Description of Works		
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out		
The apple tree in the front garden has become rotten right through the trunk and vertically up and and down through various large overhead branches and as far down as can be seen. We would estimate that at least 75% of the internal is rotten and decayed. Large dead and decayed branches have started to fall from the tree. We feel this is a danger to the public as some of it over hangs a busy public pavement and busy road junction just feet away. The tree gives no usable fruit and we propose to completely remove it before it damages property, but more importantly before it causes injury. In recent years several smaller fruit trees have been planted and so over time should infill and keep the aesthetics of the property in keeping with its original design.		

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
