Details of the pre-application advice received

If you are proposing replacing them in their entirety as opposed to undertaking repairs where needed then consent will be required. We will need to see large scale joinery details of existing/proposed to avoid any ambiguity in what work is being carried out. This would need an elevation to show existing/proposed glazing bar grid, a plan showing profile of the curved bow window, and sections through the head/jamb/sill of the frame and the glazing bars to illustrate section profiles/dimensions/glazing and to demonstrate that this will be a like-for-like replacement. There will also need to be a condition report on the existing windows which justifies their wholesale replacement as opposed to repair.
