Sycamore tree in field close to boundary of Spout House property. No preservation order exists. Land owner has given permission due to size and dominance over adjacent property and possible damage likely to be caused to chimney by over hanging branches. Whole crown reduction to 12m above ground level to provide sufficient clearance to adjacent property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
