Following on from our discussions please find below a quote to erect a new general storage building.

Building Specifications: Length 18.288m, Width 15m, Eaves height 2.7m, Roof pitch 15 degrees. Steel work to be primed and sprayed grey.

Steelwork: Stanchions 305x165x40, Rafters 254x146x31

Purlins: Z rails and eaves beam Galvanised.

Roof Cladding: box profile sheets with anti con in olive green.

Roof lights: N/A

Rainwater Goods: PVC

End Cladding: Box profile sheet in Olive Green + drip flashing

Side Cladding: Box profile sheet in Olive Green + drip flashing

Doorways: 1x personnel door, roller shutter door 4m wide x 3,5m high roller in the gable end.

Concrete Panels: .500mm panels around the base of the building.

This is subject to final design from the structural engineers. Client to pay for the building direct with the supplier, I will assist with the ordering if and when required.

To be supplied and installed by Cooks, quote is attached.

Stanchion Bases estimation.

Once materials are on site, they are the responsibility of the Client to ensure they are kept in a safe/secure location from damage or theft.

No allowance for any welfare facilities has been allowed for at present, this is assumed to be supplied by your good selves.

We will require a 4m clearance around the building suitable for access of the plant.

A clear and suitable access for articulated lorries to deliver items to the immediate work area.

Quote is subject to change due to any price increases on materials before work starts or products arrive.

Payment: is due 14 days after Date of invoice.
