## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1: Holm Oak Reduce lateral spread of canopy growing over the drive.  
T2: Holm Oak Front of house. Remove 3 lowest limbs growing over the shingle parking area.  
T3: Common Horse Chestnut Adjacent new building and Path. Reduce any extended limbs in the lower canopy growing over path to elevate end weight.  
T4: Common Horse Chestnut Adjacent above. Reduce lowest hazard beam by up to 3 metres to elevate end weight.  
T5: Twin Stem Common Alder Adjacent Bridge. Reduce in height by up to 4 metres and cut away from phone lines.  
T6: Holm Oak Reduce in height by approximately 10 metres (50%). Reduce lateral spread to shape and balance.  
T7 and T8: Lime x2 Reduce in height to match the adjacent reduced Holm oak. Remove epicormic growth from the main stem.  
T9: Sycamore x1 Reduce in height to match the adjacent reduced Holm oak. Remove epicormic growth from the main stem.  
T10: Variegated Sycamore Reduce over extended limbs to shape and balance.  
T11: Sycamore Adjacent Tennis Court. Remove limb growing towards tennis court back to the main stem. Reduce remaining 2 stems by up to 8 metres.  
Reason for works: . Allow more light, Reducing branches to elevate end weight, Lifting canopy's to avoid vehicle damage, general maintenance of trees

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

### Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
