Eucalyptus(T1) - Fell Thuja x 2(T2 & 3) - Reduce by 4m to leave at a height of 6m Yew(T4) - cut back the limbs over the road back by up to 1m back to the boundary Holly(T5) - Reduce by 3.5m to leave a height of 6m Cherry(T6) and Apple(T7) - cut back from the building to give 2m clearance
