TH/TPO/4(1984): 1No Oak: Reduction by 3m of branch on east side over house to appropriate target pruning point and removal of lowest overhanging branch on west side neighbour's boundary, reducing likelihood of roof damage in the event of branch failure. Crown raise lowest hanging branches around canopy that have been previously stub cut and shown little reactionary growth.
