T1 oak - Crown reduce all-round by 2.5m. Works required to reduce branches back from roofline and to minimise existing damage to driveway.

T2 Yew - Selective reduction on west side (building side) to give 1.5m clearance from property. Branch reduction to 'drop crotch' to suitable branch junctions only. Crown thin 30%. Work is required to give clearance to property and allow more light to windows.

Acacia T3 - Fell. Tree is decayed, leaning, and has significant dieback within upper crown.

Sycamore group (3 stems) T4 - Crown reduce 2m to give more light to garden.

Robins (2 of) at front, bordering Denmark Hill T5 - Remove deadwood and crown reduce 2m all-round. Work is required for general maintenance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
