2. Description of the proposed development:

Earthworks to form embankments either side of the HS2 railway, and other earthworks to facilitate the Ridgeway Lane diversion, maintenance access roads and pedestrian strips, road vehicle parks, a balancing pond, drainage and an ecological mitigation pond.

3. Location at which the development is to be undertaken:

The Grand Union Canal Embankment will be located approximately 1.91 km north of Ufton, 3.13 km east of Radford Semele, 3.51 km south of Hunningham and 3.5 km south west of Long Itchington. The Grand Union Canal is also adjacent to the asset's southern boundary.
