T4, T5 Beech - reduction by 1.5-2 meters height. Lateral growth timed back by similar proportions concentrating on removing weight from
laterals overhanging the car park of adjacent buildings. T6 Holly, T7 Sycamore, T8 Ash Self seeded trees growing in places that will potentially cause problems to the retaining wall in future.
T7 Cherry Light crown reduction by 1 meter

T8 Beech Crown reduction back to previously cut points. Between 1.5-2 meters.
