The plan is to create an ensuite shower room, with sink and WC in the master bedroom of the house. The house currently has no upstairs WC. Although the house has 4 bedrooms, the only family bathroom (with WC) is located on the ground floor - where there is also a small separate WC. There is a very small shower room with sink (but no WC) in one of the smaller 1st floor bedrooms - accessible only from this bedroom and in a part of the house not connected with the master bedroom as it has a separate staircase. The proposed en-suite will only take up a small part of the large master bedroom - see plans - the ensuite occupies a 1.2m slice of a room that is approx 5m wide. Construction will create minimum disruption as it is above the boiler room where all necessary pipework can easily be extended upwards.
