Details of the pre-application advice received

Being within the Beccles Conservation Area which is covered by an Article 4 Direction, any replacement windows which front a 'relevant location' such as a road would require planning permission. So long as they did not hold any significant historical interest, their replacement could be acceptable in principle. Replacement with timber sash windows would likely be an acceptable design approach. Any windows on the rear could be replaced like for like without requiring permission.

A householder planning application would be required for the replacement windows
