Following the visit on 15 February 2024 by Matt Wilson - ISA Certified Arborist, the following works were discussed and agreed with the homeowner / applicant for reasons of sound arboricultural management of trees within a domestic setting

- (1) Yew by the house.
- Trim hard all over to contain the shape.
- Raise all round to approximately 2.0m to allow more light underneath.
- (2) Cherry in the far corner.
- Remove the branch rubbing on the phone line.
- Clear the remaining branches to give approximately 30cm from the wire.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
