Oak (T1) - Crown Reduction - Reducing the height and spread of the tree by up to 2- 3 metres, leaving the tree approx. 18m tall and 15m wide. This reduction is required due to light issues and as part of ongoing management of the tree. It is very large and at its current size, it is dwarfing the property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
