T1 Willow.

Overall reduction, reducing height by approximately 4000mm, reducing width of canopy by approximately 2000mm.

T1 is a juvenile poorly formed specimen in a small urban garden, its current height is no longer in keeping with its location and remedial works are required.

as evidenced in phots the main union close to ground level features several bark inclusions which are becoming potential points of failure with the length and weight of the above leaders.

a vertical reduction of approximately 4000mm in conduction with a lateral reduction of approximately 2000mm will be used to consolidate the canopy to a smaller and more in keeping size whilst reducing the risk of limb fracture or union failure.

Works will be in accordance with BS3998, cut diameters will be up to 100mm, cutting to viable growth points wherever possible.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
