Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

- T1, Sycamore- requires a lateral reduction of 3 meters all round, and crown topped by 3 meters, crown lift by 1 limb all round. 1 major limb of 250mm diameter leaning towards house to be removed to base. remove ivy
- T2, Sycamore- requires a lateral reduction of 3 meters all round, and crown topped by 3 meters, crown lift by 1 limb all round.
- T3, Sycamore- requires a lateral reduction of 3 meters all round, and crown topped by 3 meters, crown lift by 1 limb all round.
- T4, Sycamore- requires a lateral reduction of 3 meters all round, and crown topped by 3 meters, crown lift by 1 limb all round. limbs overhanging fence to street side to be reduced back to boundary line.
- T5, Yew- in need of reshape, tree has grown in awkward direction. large portion (around 4 meters) of the crown is leaning heavily and should be removed so the tree remains standing and to encourage growth in correct direction.
- T6, Sycamore- is in poor crown shape and condition. removal suggested to give T5 more space.
- T7-Sycamore- requires a crown reduction of around 30% and a height reduction of around 2 meters
- T8, Yew, branches over hanging fence onto street side, cut back to within boundary. reshape crown, with small reduction all round.
- T9,Sycamore- requires a lateral reduction of 3 meters all round, and crown topped by 3 meters, crown thinning by 30% shorten limbs over hanging fence on street side back to boundary
- T10. Sycamore- requires a lateral reduction of 3 meters all round, and crown topped by 3 meters, shorten limbs overhanging fence back to boundary line.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) - Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
