The work is to prune three Oak Trees as follows:

- One Oak Tree at the front of the property on the boundary with 16 Gervase Road as identified in PIC 1
- Two Oak Trees at the rear of the property as identified in PIC 2

Rationale

- Some branches are weak and overhanding
- Some branches are dead
- Some of these branches fall during windy days and constitute a danger

Works

- Prune the three trees to look like the Oak Tree recently pruned by the Council further down Gervase Road as identified in PIC 3

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
