Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
There are 2 large leylandii trees in our front garden. We are proposing to cut down the largest tree which is nearest the pavement as it is a poor state of health and looks unattractive. We propose to trim the smaller tree which is nearer the house to prevent it getting too large and causing structural problems to the property.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
