During my inspection of two Ash trees, at Haddef north Waltham, Mary lane it is my professional opinion that tree number 1 outlined in my sketch, will need to be removed as it has a fungal bracket which is called (inonotus hispidus) - a heart rot fungus- that weakens the stems of ash trees. this tree overhangs 6+ phone lines and Mary lane, this is not good with the current situation with die back also. tree number 2 that is outlined in sketch, has die back and one hole stem is stone dead, my opinion this needs to be removed to.

ash tree number one to be removed due to fungal bracket and die back ash number two to be removed due to one stem completely dead and die back
