Lintels, Sills and Stonework - Levels 2 and 3 will be rendered and painted a shade of white. The top (level 4) dormer will be clad in Millboard composite cladding in Golden Oak colour. The lowest level (level 1 - the gym/study) will be covered in stone effect cladding tiles in a light grey/brown colour to attempt to blend the lowest level into the ground and reduce the perceived size of the building.
