## Description of Proposed Works

Please describe the proposed works

1. Replacement of timber frames double glazed windows to front, side and rear elevations with UPVC framed double glazed windows. Framed style (casement), glazing pattern and opening to match. Matching our neighbours' (number 61 and 63) who have switched to UPVC - agate grey windows and "Evolution" style - as close a match as possible to the original Farrow and Ball's French Grey No18 paint.
2. Replacement of composite front door in pearl grey (matching 61 and 63). As discussed in our neighbours' applications the door will have a different glazing pattern to the original as this cannot be replicated, however it will match with the door of 61 and 63.
3. Replacement of timber framed double glazed French and back door to rear with UPVC framed double glazed French and back doors in colour agate grey to match the windows.

Timber framed double glazed windows finished originally in Farrow and Ball's French grey No 18 paint.

**Proposed materials and finishes:**

Evolution Storm 70 - Casement UPVC framed double glazing from The Panoramic Window Company - A rated toughened glass. Colour of agate grey which is a match to the original paint of Farrow and Ball's No 18 and our neighbours' UPVC changes.

Front elevation composite front door with timber frame finished in a white gloss. Side and rear elevation timber framed and double glazed French doors finished originally in Farrow and Bell's French grey No 18 paint. Side and rear elevation timber framed back door finished in white gloss.

Front elevation composite front door rocal endurance 2022 colour of pearl grey. Side and rear elevation framed and double glazed French doors and UPVC back door Evolution Storm Charlton Agate grey matching the windows and the original paint colour of Farrow and Ball's French grey number 18.
