The tree has become extremely overgrown such that it is almost touching the roof of the neighbouring (No 8) shed. The leaves are also falling into the garden of number 8, which we wish to minimise as much as possible because they has a small child (14 Months) playing in the garden, and leaves of this nature could cause injury to the child.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
