T057 Norway Maple - Repollard. Historic heavy reduction/topped Damaged roots. Exposed roots. G22
T069 Honey Locust - Prune to clear building by 2m. In walled planting pit. G2
T077 Sycamore - Prune to clear building by 2m. Crown lift to 5.2 m for highway clearance. Exposed and damaged roots. G5
T087 Honey Locust - Crown lift to 2.4m for pedestrian clearance. In walled planting pit. G7
T088 Wild Cherry - Crown lift to 2.4m for pedestrian clearance. Prune to clear building by 2m. Historic heavy reduction / topped Ivy on stem. In walled planting pit. G7
T138 Purple Cherry Plum - Crown lift to 2.4m for pedestrian clearance. Leaning trunk. Suppressed by neighbour. G8.
T139 Norway Maple - Crown lift to 2.4m for pedestrian clearance. Prune to clear building by 2m. Dead branch(es). Minor Unbalanced crown. Exposed roots, damaged roots, girdled roots. G8
T160 Apple - Crown lift to 2.4m for pedestrian clearance. Historic heavy reduction/topped. Dead branch(es). Minor. In walled planting pit. Leaning trunk. G15
T171 Silver Birch - Crown lift to 2.4m for pedestrian clearance. Crown lift to 5.2 m for highway clearance. Historic heavy reduction. G17
T178 Silver Birch - Prune to clear building by 1m. T6.
T196 Norway Maple - Remove damaged & dying limbs. Missing bark/bark dysfunction at multiple areas throughout crown. Dieback in centre of crown. G14
T220 English Yew - Crown lift to 2.4m for pedestrian clearance. Prune to clear building by 1m. T9
T251 Common Ash - Pollard limb over neighbouring property to match existing pollard points. Pollarded at 7m, recently repollarded, limb over neighboring property not cut. G19
T253 Sycamore - Pollard limb over neighbouring property to match existing pollard points. Pollarded at 7m, recently repollarded, limb over neighboring property not cut. G19
T260 Common Lime - Crown lift to 2.4m for pedestrian clearance. Prune to clear lamp by 1m. G12
All works completed in accordance with BS3998:2010 standards.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
