The work previously granted permission for was not carried out and neighbours concerned about potential damage to their property from overhanging tree limbs.

We wish to reinstate this permission to carry out the removal of 2 lowest tree limbs overhanging property boundary with no 26 and crown lift canopy to height of 4.5 metres
